### Represent MAFP at NCCL in 2023

Believe it or not, it’s time to start planning your schedule for AAFP’s spring leadership conferences. The 2023 [National Conference of Constituency Leaders \(NCCL\)](#) will be held Tuesday-Thursday, May 9-11, 2023, in Kansas City, MO.

During NCCL, you will meet family physicians from across the United States, discuss and develop resolutions that shape AAFP policies and have the chance to be elected for various leadership positions for the next NCCL or as a delegate to the annual AAFP Congress of Delegates. MAFP delegates to NCCL each receive travel reimbursement according to the MAFP reimbursement policy.

The MAFP is looking for physician members who can represent five recognized special constituencies:

- International Medical Graduate (IMG) (an active member of the AAFP who graduated from a medical school outside the U.S., Canada, and Puerto Rico)
- LGBTQ+ Physician or Ally (an active AAFP member who self-identifies as LGBTQ+ or who is supportive of LGBTQ+ issues)
- Minority (an active AAFP member who is African American, Native Hawaiian or Pacific Islander, American Indian, Alaska Native, or ethnic Latino)
- New Physician (an active AAFP member who has been in practice for less than seven years)
- Women (an active AAFP member who is a woman).

## Other News and Updates

### MO Health Professional Student Loan Repayment Program (SLRP) Accepting Applications

The SLRP program will be accepting applications from January 1 to March 1. The SLRP is a competitive federal grant program that allocates funds to states to award funding for educational loan repayment to Missouri licensed practicing psychiatry, medical, and dental health professionals in exchange for services in Missouri areas with a shortage of mental health, medical, and dental professionals. Repayment amounts up to \$50,000 are available for eligible primary care physicians and dentists (MD, DO, DDS, DMD).

SLRP recipients earn forgiveness of their loan repayment award through a service obligation. The obligation is two years of service per award, which is based on full-time qualifying employment.

Qualifying employment is considered as full-time, direct patient care in a HPSA providing primary health care services. You can search for HPSAs here. Full-Time employment in the SLRP is considered forty (40) hours per week. Hospitalists, emergency medicine physicians, and positions in inpatient facilities, and prisons do not qualify.

### MoHealthNet Albuterol Inhaler and Nebulizer Quantity Limits

Quantity limits for [albuterol inhalers and nebulizer solution](#) went into effect on August 18, 2022. Adults are now limited to 3 albuterol inhalers (300 rescue doses) every 180 days. Participants of all ages are limited to 120 vials every 2 months.

If a physician or provider feels a patient needs albuterol inhalers or nebulizer solutions in excess of these limits, a letter of medical necessity and progress notes will need to be submitted.

Other things to consider when submitting an exception:

- Is this patient prescribed a controller medication?
- Is this patient using that controller medication as prescribed?
- Does the patient need a higher dose or additional controller medication?
- Are there alternate medications (i.e. SMART for asthma) that could be utilized with this patient?
