Other News and Updates

X-Waiver to Prescribe Buprenorphine Clarification

As you may <u>have seen</u>, year-end legislation repealed the x-waiver to prescribe buprenorphine. <u>DEA</u> and SAMHSA have released statements confirming the X-waiver requirements and patient caps have been removed. However, the year-end legislation included a separate provision, known as the MATE Act, that requires prescribers of controlled substances in schedule II, III, IV, and V to complete a one-time eight-hour training to obtain or renew their DEA license. SAMHSA and the DEA have not yet released official guidance or embarked on rulemaking for this provision. This is completely separate from the x-waiver changes.

The AAFP is working closely with SAMHSA, DEA, and other stakeholders on a number of recommendations to ensure this provision does not unduly burden physicians or reduce patient access to care. At this time, SAMHSA and DEA have some discretion on how this is implemented, what training will meet or has already met the new requirements, what documentation is required, and how the timeline for this training will be established. The AAFP will share these details as soon as possible and work with chapters and our continuing education staff to ensure our family physicians have access to the resources they need to renew their prescribing licenses. This provision may go into effect June 21, 2023 at the earliest, but again, we are awaiting further clarification on the timeline from the DEA. If your DEA license expires in 2024 or later, you will not need to complete any additional training this year unless you choose to do so.

CDC Adds COVID Vaccine to Routine Immunization Schedule for Kids, Adults

COVID-19 vaccines are now included among the routine shots recommended by the Centers for Disease Control and Prevention (CDC) for children, adolescents, and adults. The 2023 list includes shots for the flu, measles mumps and rubella, polio, and other inoculations. The vaccine schedule represents the current recommendations for people as a regular part of their vaccinations against common infectious diseases. Read more in The Hill.

COVID Public Health Emergency Ending March 11

The Biden Administration <u>announced</u> the Public Health Emergency (PHE) will end on May 11, 2023. The decision to bring the PHE to a close is one the AAFP has anticipated, and their course of action is consistent with their previous commitments to provide at least 60 days' notice prior to the termination of the PHE. AAFP's response on the impact of the PHE wind down can be found in a <u>letter</u> sent to President Biden with updated recommendations for ensuring continuous access to care when the PHE expires on May 11. CMS released a <u>fact sheet</u> outlining programs impacted by the wind down of the PHE.
